

## FRANCHISE OFFER TERMS AND CONDITIONS

### INTRODUCTION:-

M/s Beauty Hair Supply and Beauty Care is a proprietary concern having its principle office at 10 Tarak Dutta Road, Ground Floor, Eden Terrace, Kolkata - 700 019. M/s Beauty Hair Supply and Beauty Care is involved in business of Hair Weaving, Hair Fixing and Hair Browning, Non-Surgical Hair Replacement System amongst other hair care services. M/s Beauty Hair Supply and Beauty Care also supplies specially manufactures/sources hair care products like Hair Gel, Shampoos, Hair Cream, Jelly amongst other products in order to help aftercare of Hair Services as mentioned. M/s Beauty Hair Supply and Beauty Care starting from a single shop in Kolkata on .....(DATE)..... have already extended to ..... outlets. It also owns a manufacturing unit at .....(place)....., manufacturing its own products thus providing competitive rates for its products and services. Its business being based in Kolkata in land and buildings owned by the proprietor itself it is financially self-sufficient. ### Section 1: Services, Terms & conditions

1. M/s Beauty Hair Supply and Beauty Care would provide their entire range of services by own or through the service providers which includes of Hair Weaving, Hair Fixing and Hair Browning, Non-Surgical Hair Replacement System amongst other hair care services, value added services and premium services to the "Franchise". A complete list of services provided by us is Annexed herewith and marked with Letter "A".
2. "Franchise" will act as a single point hub for all services provided by M/s Beauty Hair Supply and Beauty Care falling within the purview of this agreement.
3. M/s Beauty Hair Supply and Beauty Care will publish commission structure and earning of the "Franchise" from time to time in their web site. The details of all transactions done by "Franchise" will be available on the web, login ID and password of which will be provided to "Franchise" upon registration. "Franchise" will keep enough funds with M/s Beauty Hair Supply and Beauty Care so as to cater all transactions to provide services to the customers.

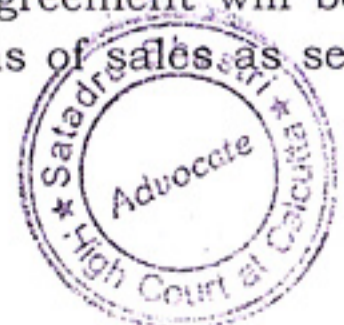


#### **Section 4: Eligibility Criteria and Process of Registration**

1. Any person, persons, organisation and/ or institution should have the following criteria in order to apply for "Franchise" :-
  - (a) Should own and/or rent at his/her/their own expenses a comfortable air-conditioned premises wherein hair care services could be provided comfortably to customers. Such premises will be verified by the officers or owner of M/s Beauty Hair Supply and Beauty before acceptance.
  - (b) The person, persons, organisation and/ or institution passing the above criteria requires to register for "Franchise" by deposit of a Security amount of Rs. 10,00,000/- (Ten Lakh) only. This amount is refundable only in the form of materials purchased.
  - (c) Once registered a Registration Certificate will be provided along with a adequate slot for the franchise in the Company's website.

#### **Section 5: Services to be provided by M/s Beauty Hair Supply and Beauty Care**

1. M/s Beauty Hair Supply and Beauty Care will provide technicians for Hair care services to its Franchises. In case the franchise has their own trained beauty and hair care technicians, M/s Beauty Hair Supply and Beauty Care will provide adequate training sessions.
2. All materials required for treatment of hair and other products related to our services or otherwise will be provided by M/s Beauty Hair Supply and Beauty Care.
3. M/s Beauty Hair Supply and Beauty Care will provide business know-how to "Franchises" about all products and services provided by us.
4. Sessions of product description and/or business know-how will be held in various cities throughout the country of India.
5. Online sessions of product description and/or business know-how will be held online through the company's website.
6. All the services falling within the purview of this agreement will be made to "Franchise" based upon standard conditions of sales as set



by company for all its "Franchise" outlets from time to time. Such conditions will generally be in line with conditions that are placed upon Franchise by various service providers and also as a result of business decisions, legal and contractual requirements.

7. "Franchise" will keep providing the services within the purview of this agreement through their outlets exclusive with M/s Beauty Hair Supply and Beauty Care. "Franchise" will not enter into direct agreements with any other services providers, aggregators, distributors or any similar entity in India for this purpose, for the duration of this agreement.
8. The Intellectual Property rights including the concept of delivery of services will rest with M/s Beauty Hair Supply and Beauty Care or its suppliers or service providers.
9. M/s Beauty Hair Supply and Beauty Care and "Franchise" shall conduct their business at all times, in accordance with the applicable statutes, regulations, notification etc., Issued by the Government or any other statutory authority.

#### **Section 6: Confidentiality**

1. "Franchise" shall keep all information of confidential nature received from the company in whatever form as strictly confidential and shall not disclose it to third Parties without the prior written consent of M/s Beauty Hair Supply and Beauty Care during the term of this Agreement.
2. "Franchise" agrees not to disclose revenue Information without prior written consent.
3. Any "Franchise" found to disclose any material know-how to any organisation; person and/or persons without consent of the company will be booked for "Insider-Trading" and "Fraud" as per the provisions of Law. Both Civil and Criminal proceedings will be initiated against such defraud.



## Section 7: Applicable Law

"Franchises" registered will be accompanied by an "Memorandum of Understanding" (MOU). All "Franchises" will be governed by the Applicable laws to franchises and MOU.
